



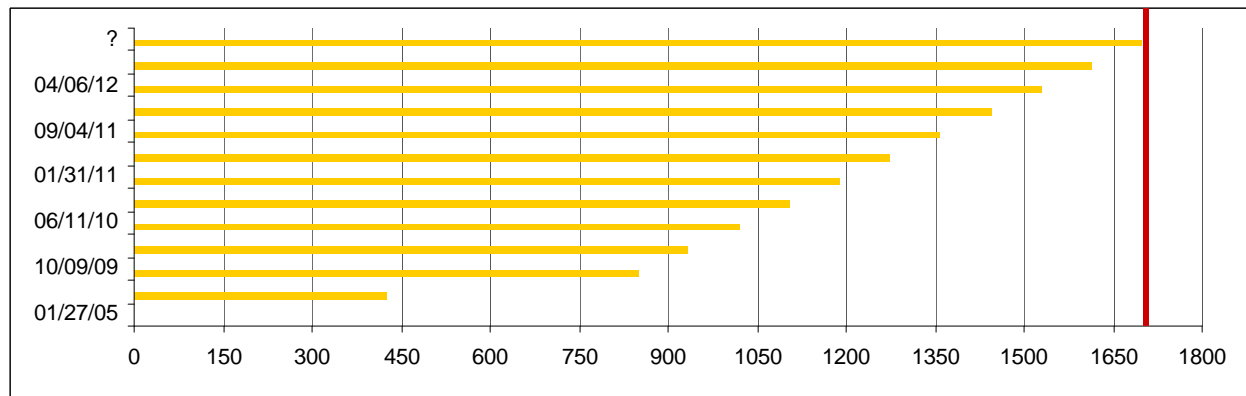
**FAST-MAG SETS A NEW STANDARD OF CARE:  
THE DIAMOND HALF-HOUR**

Optimal time for treatment in trauma and emergency care is “The Golden Hour” – 60 minutes after onset. Until now, treating stroke patients in the golden hour was seen as a worthy but extremely difficult goal. In previous stroke studies with thousands of patients, only 10 (ten) were ever enrolled in less than one hour. FAST-MAG has enrolled almost 1,200 patients in less than one hour – all in the prehospital setting. Even more stunning is that nearly 160 of those patients were enrolled in **30 minutes or less**. Los Angeles and Orange County paramedics have helped establish a new time window in stroke care: *The Diamond Half-hour*. Congratulations!
